The Ministry of Environment, Urbanization and Climate Change (MoEUCC) has received financing from the World Bank toward the cost of the Energy Efficiency in Public Buildings Project (EEPBP) and intends to apply part of the proceeds for consulting services. General Directorate of Construction Affairs (GDCA) of MoEUCC will serve as the main implementing agency for the Project. The overall objective of EEPBP is to reduce energy use in central government buildings and develop a transition plan to develop and scale-up suitable sustainable financing and institutional mechanisms to support a national program. The implementation period will be finished by end of 2025.

The consulting service (“the Services”) includes the hiring of a full-time a **Communication and Stakeholder Engagement Specialist** (Ref: EEPB/WB/MOEU/PIU-IND-CS-01) to support the GDCA’s Project Implementation Unit. The selected consultant is expected to be awarded with one-year renewable contract.
